Any omission/suppression of information/fake information shall lead to rejection of application or candidature at any state of the process without further intimation and selection will be made through open competitive examination conducted by the Block Selection Committee. Eligibility Criteria:

- 1. Must be a Woman and a member of existing Self-Help Group Member.
- As on 01-01-2024, age is within 21-35 years.
- 3. Must have passed HS or Equivalent Examination. But Higher qualification will be preferred.
- 4. Resident of that Gram Panchayat area.
- 5. Basic Knowledge in Computer.
- 6. Must have an android Mobile & have Knowledge in operation of Android Mobile.
- Should have clear and sound knowledge about functioning of SHGs / SHG based Federations, Book Keeping, Audit, Financial Inclusion, MIP, PIP process etc.
- 8. Must have desire to learn new skills & acquiring knowledge and is physically fit.
- 9. Must not continue to act as an office bearer of any Up Sangha/Sangha/Maha Sangha.
- 10. Must not continue to act as an employee of office bearer of PRI(GP/PS/ZP).
- 11. Must not continue to act as an ICDS Worker/Helper and ASHA Worker.
- 12. Must not continue to act as a full-time employee of Government organization/NGO.
- 13. In need, willing to go outside Block/District/State.

NB:

- The Block Selection Committee will reserve the right summarily to reject any application or candidature for suppressing any information / documents / facts relating to age, educational qualifications etc. and incomplete application. It also reserves the right to cancel / postpone / suspend at any point of stage.
- 2. Any canvassing or adopting unfair means will lead to cancellation of candidature.
- 3. In case of any dispute, the decision of Selection Committee shall be final.
- Engagement will be on purely Incentive basis and could be terminated before the tenure in case of non-satisfactory performance.

- 7. The candidate will have to produce his / her original certificates & testimonial to enable the authority to verify his / her date of birth & educational qualifications at the time of reporting. Any discrepancy between original documents and claims made by candidate will be treated as misrepresentation / suppression of material facts for wrongful gain and summarily or application will be rejected and legal action will be taken.

 - g. Breach of Trust or Breach of Confidence with reference to the official secrets.
 - h. Involvement in criminal activities leading to more than 48 hours of Police Custody or Jail at the investigation stage.
